Carne Global Fund Managers (Luxembourg) S.A. (the "Manager") is authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier. The key information document is accurate as at 19 February 2025.

➤ What is this product?

Type: This product is a SICAV.

Term: No fixed term.

Objectives: The investment objective of the sub-fund is to achieve capital growth in the medium term by investing mainly in High Yield Global Bonds and Emerging Market bonds and to generate a total rate of return in excess of a composite Benchmark comprised of 50% ICE BofA Euro High Yield Duration-Matched ESG Tilt Index and 50% ICE BofA 1-5 Year BBB & Lower Sovereign External Debt Carbon Reduction Constrained Index hedged (each an "ESG Index" and, collectively, the "ESG Indices"). The Sub-Fund is actively managed in reference to this Benchmark with significant degree of freedom.

The Sub-Fund invests primarily in corporate and government bonds, both investment grade and high yield, issued by companies domiciled in OECD countries and in emerging markets, denominated in G-10 country currencies, (i.e. USD, Canadian Dollar, EUR, GBP) with maturity shorter than 5 years. The investments in bonds whose country risk is related to a single emerging market country will not exceed 10% of the Net Asset Value.

The Sub-Fund may also invest in bonds with maturity exceeding 5 years, in other interest bearing securities, in units of UCITS and/or other eligible UCIs with similar investment policies, liquidity and in time deposits.

The Sub-Fund may also invest: up to 20% of the Net Asset Value in securitized products (e.g. ABS, CLOs); up to 20% of the Net Asset Value in convertible bonds; up to 20% of the Net Asset Value in contingent convertible bonds. The Sub-Fund may also invest in derivatives, both exchange traded and OTC on, for instance, credit indexes, single name and/or interest rates. Such derivatives usage can be for investment purposes and for the purposes of efficient portfolio management (i.e. hedging purposes) of the Sub-Fund.

The Sub-Fund does not actively invest in defaulted and distressed bonds. Investment in defaulted and distressed bonds is not expected to be meaningful and in any case it will not exceed 10% of the net assets of the Sub-Fund. Disposal or sale of defaulted or distressed instruments will be pursued in the interest of the investors. Currency risk will be mostly hedged, residual risk may remain. The interest rate duration of the Sub-Fund will be, on average, between 1 and 5 years.

Intended retail investor: The Sub Fund is suitable for investors who have ESG preferences, who are seeking capital appreciation over 5 Years and are prepared to accept risk to their capital and at least moderate volatility in the value of their investments. Given the investment objective and policies of the subfund, the subfund is suitable for conservative investors including those who are interested in or informed about capital market topics but see investment fund as a convenient saving product. It is also suitable for more experienced investors wishing to attain defined investment objectives.

Depository: The Fund's assets are held through its Depository, which is BNP Paribas S.A., Luxembourg Branch.

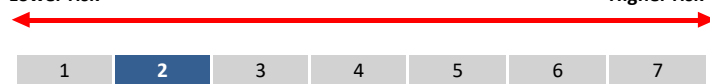
Distribution type: The product is accumulating.

➤ What are the risks and what could I get in return?

➤ What happens if Carne Global Fund Managers (Luxembourg) S.A. is unable to pay out?

➤ What are the costs?

Costs over time

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return)
- For the other holding periods we have assumed the product performs as shown in the moderate scenario

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 1.22% before costs and 0.49% after costs.

➤ How long should I hold it and can I take my money out early?

The recommended minimum holding period: 5 years.

The Fund is designed to be held over long term and we recommend that you hold this investment for at least 5 years. You can request to take out some or all of your money at any time. You can typically request to buy or sell shares in the sub-fund on any business day (as set out in the Fund's prospectus). Investors may demand to redeem their units every normal bank business day in Luxembourg.
